## Christmas Message 2019

Dear Clients and Friends,

Hard to believe it's almost the end of 2019 and a new decade is around the corner. If you're a new reader to the **Tax Tipper**, welcome. Since 2000, <u>www.ptccanada.com</u> has been servicing our clients via monthly bulletins, <u>newsletters</u>, <u>resources</u>, and more. Our <u>revamped website</u> has been up for almost a year, with more tools to help you and simply to get the job done fast. The need for good information has moved from important to critical as the world goes into overdrive with change. This is a critical time in history, and I have lots to discuss. I'll try my best to do it in two pages, hitting the important parts.

The October election was disappointing to many Canadians, as we are in for four more years of hard times. Let's face it: the Liberals are the most reckless politicians ever known in our history, and the recent job report of over 70,000 losses will be felt nationally. Andrew Scheer's resignation, due to using election funds for personal use, is just the tip of the spear of the corruption about to bubble out. Premier Jason Kenney has not only been fighting hard for his province of Alberta but for many middle-class working people across the country. Even in Quebec, they object to foreign oil and overwhelmingly prefer that the West provide for their energy needs.

Energy has been a vital commodity to Canada, not just for financial reasons but for running the country in general. When you have winter in some parts of the country for most of the year, energy can make or break a region. Many are now rejecting the climatechange hoax, since there is no data to support any of the claims. And, no surprise, <u>the</u> <u>mainstream media is in freefall across the</u> <u>world</u>. In fact, <u>CBC's ad revenues fell over</u> <u>53% in the last five years</u>; and without taxpayer money, CBC would have been long gone. At the provincial level, Premier Jason Kenney has been a proponent of a <u>fair deal for Alberta</u>, as he wants to be free of federal tyranny—and I believe he will be successful. Now this will be a witness for other provinces, who will inevitably start demanding the same. The idea is to decentralize power from the federal government to the provinces and ultimately the people. I believe this is what's behind the <u>Wexit movement</u>, but I can't see that working today. If Kenney pulls this off and turns Alberta around by the next federal election, I expect him to be the conservative leader for the 2023 election. Being bilingual and familiar with how the federal government works, he's a good résumé candidate. I can't think of any viable member of the Conservative Party of Canada who can win the next election, and we absolutely have to have a majority if we are to get our country back.

There's one more nagging factor that has brought a devastating blow to the deep state. <u>Project Veritas</u> last month dropped a <u>leaked video</u> of ABC anchor <u>Amy Robach</u> that went totally viral about <u>convicted human trafficker Jeffrey Epstein</u>. It was so poignant that ABC had to admit the whole story was true. Since then, Prince Andrew has been kicked out of the palace after his <u>disastrous interview with BBC</u>, which was <u>countered by victim Virginia Roberts</u>. ## Is Retirement Really Unemployment-Universal Income Looming for Canadians?



#### A recent article in USA Today, entitled If

you're saving for retirement, remember this: It's really just 20 years of unemployment, is intriguing in many ways. The traditional <u>40-40-40 rule of life!</u> (work 40 hours a week for 40 years for a \$40 gold watch) applied for several generations. But that all began to change in the 1980s.

Retirement has become a luxury simply because many can't afford to do it. With bouts of unemployment, crashes in the stock market, and companies going overseas, retirement is looking much more like unemployment. A <u>Knowledge</u> <u>Bureau article</u> has tried to address a few scenarios, but watch for <u>Universal Income</u>, being pushed by <u>Andrew Yang</u> in the US elections, to become a reality next decade. Looking back, we've had similar programs, such as CPP, disability benefits, EI, welfare and more, which pay people not to work. I am not a fan, because these programs send the wrong message, but unless there is an awakening about the control we give government, expect to see more of this in a few years.

## To Buy or Lease My Next Car? That's the Question!



If you run your own business or have deductible employment expenses,

chances are you need a vehicle. I've been getting questions about this since the day I started in the tax business, and while I do address some of it in <u>Small Business Tax Booklet</u>, you really need to run the numbers. ## 2020 RRSP, DPSP, TFSA, Maximum Pensionable Earnings Limits and More

#### Dear Neel,

I've been assessed for the years from 2009 to 2018 for personal taxes, GST, and BC medical for over \$100,000 as I haven't filed since 2008. I've lost all my receipts for my business and have no idea how to get started. Can CRA start seizing my bank account and assets for this amount, which I know is too high? If so, what can I do?

#### Dear Macy,

CRA is in a legal position to collect this amount, since you've been asked several times to file the required returns, without compliance. BC medical is assessed in a similar way. I highly recommend you get a professional. What they will charge you in bringing you up to date will be more than worth it in savings.

Our <u>Small Business Tax Booklet</u>, with <u>Excel business</u> <u>spreadsheet</u> and <u>Personal Tax Checklist</u>, will help you get started. Once all the returns are filed and assessed, you'll have to contact <u>BC Medical</u> directly to update them to settle the correct balance owing. If you owe a balance with CRA, contact the <u>collections department</u> to arrange payments. If the plan is too burdensome, contact a bankruptcy trustee, as they can usually negotiate a plan without filing for bankruptcy.
