
Clients Already Booking 2021 Appointments






CRA has a <u>new webpage for</u>

COVID-related issues. Whether it's about the new Canada Recovery Benefit, one-time tax-free payment of \$600 to more Canadians with disabilities, or more, this is a good starting point. Also, be sure to check your provincial or municipal website for similar entitlements. Things seem to be changing a lot and while I get questions about it, I am more focused on the tax end of things. For example, those claiming Canada Emergency Response Benefit (CERB) want to know how it affects their taxes and small business. The small business is more of a policy issue with CERB but it is taxable and can be low/not taxable if your business was showing a loss. More to come as this develops into the New Year but you can contact them for further details.

2021 RRSP, DPSP, TFSA, Maximum Pensionable Earnings Limits, and More



Each year, the finance department sets limits for different programs based on the budget, feedback, and more. CRA Auditors Targeting Small Businesses During Lockdowns?

Sorry WE'RE GLOSED

Just when you think it couldn't get any worse for small businesses who've been shutdown, regulated to death, and with practically no income, now they seem to be targeted for audits. The Canada Revenue Agency (CRA) is not elaborating on a spike in audits of small businesses who benefited from the Canada Emergency Wage Subsidy. Opposition parties last month in the House of Commons voted on a Conservative motion to suspend audits on Canadians for the next seven months. The motion calls on the "government to immediately pause the audits of small businesses that received the Canada Emergency Wage Subsidy until at least June 2021 and provide additional flexibility in the Canada Emergency Rent Subsidy, the Canada Emergency Wage Subsidy, and other support programs." However, according to Blacklock's Reporter, the CRA would not provide further information on where auditors have been allocated since relocating 3,000 of them to focus on coronavirus programs on April 21.

No End in Sight for Canadian Debt

It is official; our <u>national debt will pass \$1</u>
<u>Trillion</u> and there is no end in sight. According to a <u>Toronto Sun article</u>, the federal deficit increased from \$19 billion to \$381 billion in



just nine months. You do not have to be too smart to realize we'll never pay this back, and I personally believe there is a new financial system ready to replace this with a gold-backed system. Watch for more developments on this in the New Year.

"Can't Get a Refund No Matter What I Do"



Dear Neel,

I have not filed since 2011, and I always used to get a refund since I am a commissioned salesperson and still am. My 2010 was reassessed wrong, and I cannot seem to get that fixed. I have tried to explain to the call center for over 3 years I was wrongfully charged for income that was not mine. Is there any way to get this removed? I previously owned a business that went through an audit, but it was all clean so outside of a rude auditor, I do not think it is relevant.

Dear Michelle S.,

Not so fast, sometimes notes on a file from a previous audit can wrongfully "blacklist" a taxpayer's file and it has to be investigated. It may be time to get a professional who specifically understands this process as it is usually a triangulation of collections, assessments, and adjustments. Depending on the amount involved, etc., your representative may have to request the minister intervenes and that is something the public's not usually used to doing. In the meantime, file the other returns since refunds are coming and that helps your cause. Assuming you have the Declaration of Conditions of Employment Form T2200 on file, our Employment Expense Tax Booklet with Excel bookkeeping spreadsheet and Personal Tax Checklist will help you get started. Once all the returns are filed and assessed you'll have to contact the collections department to request the hold be released and refunds be issued. I realize this is the short version of it, but it can get fairly involved depending on each case which is why I recommend hiring a qualified person. 

Saturn & Jupiter Conjunction Happening on the Winter Solstice December 21st, 2020

Jupiter and Saturn will put on a public show that has not been seen in roughly 800 years. Astronomers are calling it the Great Conjunction of 2020. On December 21st after sundown on the winter solstice the two largest planets in our solar system will appear to almost merge in Earth's night sky. During the event, they will sit just 0.1 degrees apart, 1/5 the width of the moon. Many will ask "What are those large, bright objects so close together in the sky?" Even rarer, Jupiter and Saturn will be so close that you will be able to fit them both in the same telescopic field of view. The last time Jupiter and Saturn were this close together was in 1226 A.D., at a time when Genghis Khan was conquering large swaths of Asia, and Europe was still generations away from the Renaissance. Humanity will not have to wait quite as long to see the solar system's two largest planets repeat this month's performance, though. Another Great Conjunction will occur in 2080, so unless you can wait around, do not miss this one!
